Medicare overview

Understanding Parts A, B, C, and D

Medicare is a federal health insurance program that provides health care coverage to millions of Americans. It's part of Social Security and designed to protect the health and well-being of those who use it.

There are 4 parts to Medicare: A, B, C, and D. Each part covers specific services, from medical care to prescription drugs. On the following page, you can read about each part to better understand what coverage best fits your needs.

Every year in late September, Medicare-eligible households receive the *Medicare & You* handbook by mail. This official handbook has important information about Medicare benefits, costs, rights and protections, health and drug plans, and answers to common questions. Additional notes

- Original Medicare includes Medicare Part A (hospital insurance) and Medicare Part B (medical insurance) and is provided by the U.S. government as a federal health insurance program.
- With Original Medicare alone, you will pay deductibles and coinsurance for most services.
- Medicare Advantage plans (Part C) offer all the benefits of Original Medicare but usually have lower and more predictable out-of-pocket costs, and may offer extra benefits not covered by Original Medicare like vision, hearing, dental, and fitness.



Combine the affordable benefits of Advantage Plus with your Kaiser Permanente Medicare Advantage (HMO) plan. You can purchase Option 1 or Option 2 or combine them together.

Option 1: Only \$18 a month gets you Advantage Plus coverage along with your Medicare health plan. You'll get an additional comprehensive dental allowance, plus hearing aid and eyewear benefits. **Option 2: \$23 a month** gets you an additional comprehensive dental allowance.

When to enroll

There's a limited time to enroll in Advantage Plus. It depends on when you enroll in a Kaiser Permanente Medicare health plan.

If you are not currently enrolled in a Kaiser Permanente Medicare health plan:

- Go to kp.org/medicare to fill out the online enrollment form and choose the Advantage Plus option.
- Or sign up for a Kaiser Permanente Medicare health plan with Advantage Plus over the phone with one of our Kaiser Permanente Medicare specialists.

If you are a new Kaiser Permanente Medicare health plan member or you have moved to a different Kaiser Permanente service area:

 You can add Advantage Plus within 30 days of your Kaiser Permanente Medicare health plan's effective date.

If you are an existing Kaiser Permanente Medicare health plan member:

 You can sign up for Advantage Plus from October 15, 2024, until March 31, 2025.
 (Your enrollment form must be received in our office by this date.)



When to enroll

Initial Enrollment Period



You can first sign up for Part A and/or Part B during the 7-month period that begins 3 months before the month you turn 65, includes the month you turn 65, and ends 3 months after the month you turn 65.

General Enrollment Period



If you do not sign up for Part A and Part B when you're first eligible, you can sign up between January 1 and March 31. When you sign up during this period, your coverage starts the first day of the month after you sign up.

Special Enrollment Period (SEP)



If you continue to work past age 65 and have delayed your enrollment in Medicare Parts A and B, you have up to 8 months from the date you retired to enroll in Medicare Parts A and B to avoid a late enrollment penalty.


